

ORDINANCE AUTHORIZING A LEASE AGREEMENT BETWEEN THE CITY OF SYRACUSE AND ONONDAGA COUNTY RELATIVE TO A BUILDING ON THE PROPERTY LOCATED AT 6660 EAST SENECA TURNPIKE ON BEHALF OF THE DEPARTMENT OF PARKS, RECREATION & YOUTH PROGRAMS

WHEREAS, the Commissioner of Parks, Recreation & Youth Programs has requested that this Common Council authorize a lease agreement with Onondaga County relative to a building currently known as the Second Chance Canine Adoption Shelter on the property located at 6660 East Seneca Turnpike, Jamesville, New York 13078 (hereinafter referred to as "the Premises"), for \$1.00.; and

WHEREAS, the lease shall be for the period April 1, 2023 through March 31, 2024 with the option of two (2) additional one year extensions for the periods of April 1, 2024 through March 31, 2025 and April 1, 2025 through March 31, 2026, subject to approval of the Mayor and Common Council;

NOW, THEREFORE,

BE IT ORDAINED, that the Commissioner of Assessment, on behalf of the City of Syracuse, be and he hereby is authorized to execute a lease agreement under the following terms:

- (1) The lease agreement shall be for the Premises for the purpose of enabling City and City staff to work inside the facility to move dogs from the contracted City shelter to the Premises, with the goal to adopt them out in coordination with Friends of Second Chance Shelter Inc;
- (2) The term of the lease shall be for one (1) year for the period April 1, 2023 through March 31, 2024 with an option of two (2) additional one year extensions for the periods of April 1, 2024 through March 31, 2025 and April 1, 2025 through March 31, 2026, subject to approval of the Mayor and Common Council;

(3) The City shall pay the County nominal rent of \$1.00 for the term of the lease; and

BE IT FURTHER ORDAINED, that said lease agreement shall be subject to the approval of the Corporation Counsel as to terms, form, and content.

BE IT ORDAINED, that Ordinance No. 743-2022 is hereby amended as follows:





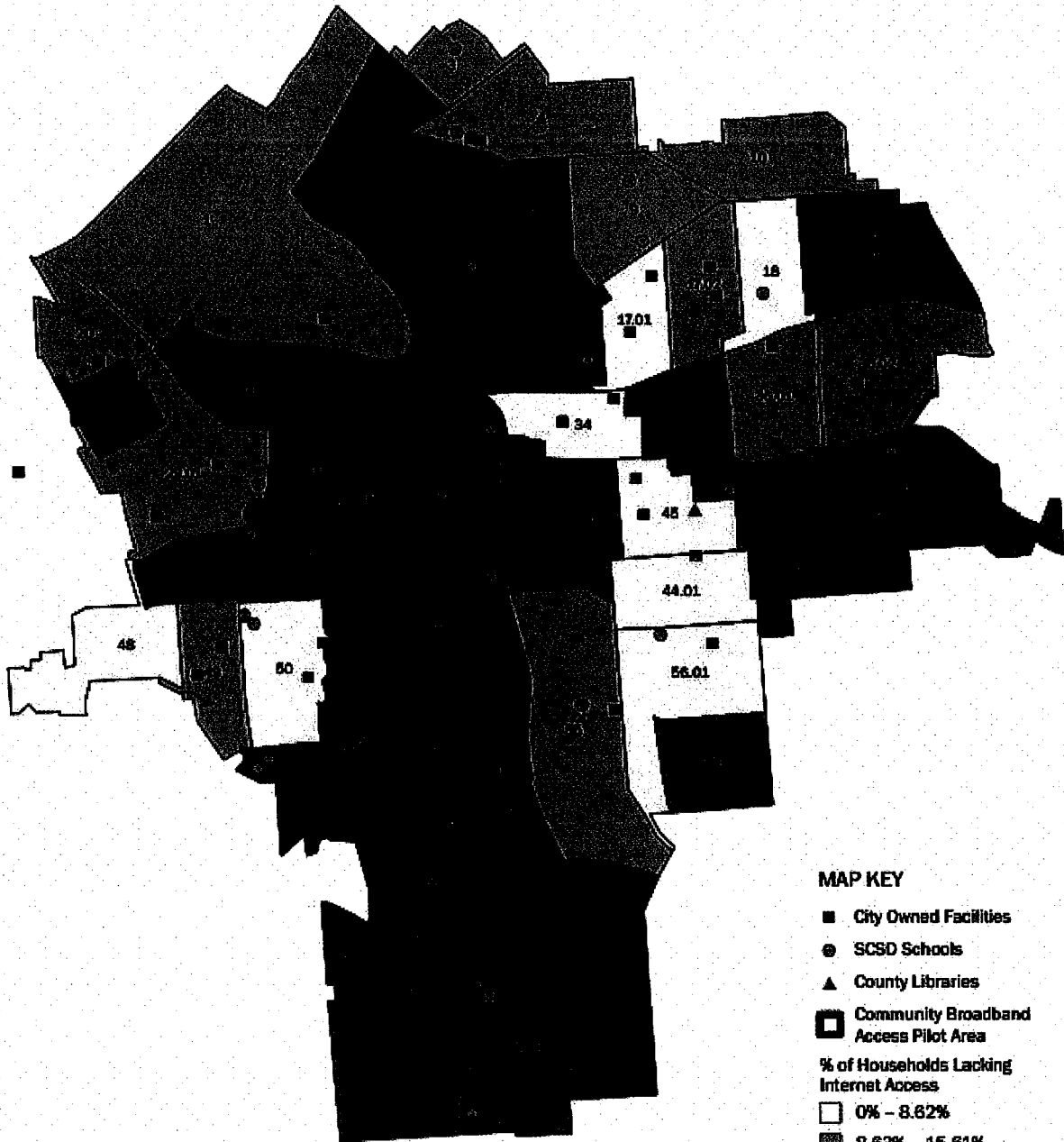

ORDINANCE AUTHORIZING A CONTRACT WITH CBN GENEVA LLC D/B/A CBN-SYRACUSE LLC FOR SERVICES RELATIVE TO THE CITY OF SYRACUSE COMMUNITY BROADBAND PILOT PROGRAM TO PROVIDE AFFORDABLE INTERNET SERVICE TO LOW INCOME FAMILIES IN THE CITY OF SYRACUSE

WHEREAS, Section 5-205-A of the Charter of the City of Syracuse, as amended, provides the Mayor shall "award contracts for professional services subject to the approval of the Common Council"; and

WHEREAS, the City conducted a Request for Proposals (RFP) for services relative to the establishment of a Community Broadband Program for the City of Syracuse to help address the digital divide and provide affordable internet service to low income families residing in the City of Syracuse; and

WHEREAS, after reviewing the proposals submitted in response to the RFP, the RFP Committee has recommended to the Director of the Office of Management and Budget and the Mayor that the Community Broadband Pilot Program should consist of a fixed wireless municipal broadband network and that a contract should be awarded to CBN Geneva LLC d/b/a CBN-Syracuse LLC to establish a fixed wireless municipal broadband network for the City of Syracuse; and

WHEREAS, the Mayor has approved the retention of CNB Geneva LLC d/b/a CBN-Syracuse LLC (hereinafter referred to as the "Consultant") under the following terms:

- (1) The Consultant shall provide all required services necessary to install, maintain, and operate a municipal broadband network to provide affordable internet service to low income families. The internet network will be piloted in ten (10) census tracts facing the largest digital divide in the city as detailed in the map attached hereto as Exhibit "A". The provider will also conduct marketing, enrollment and ongoing resident

support services. The program will be designed to provide service for 2,500 households in the City of Syracuse each year of the agreement.

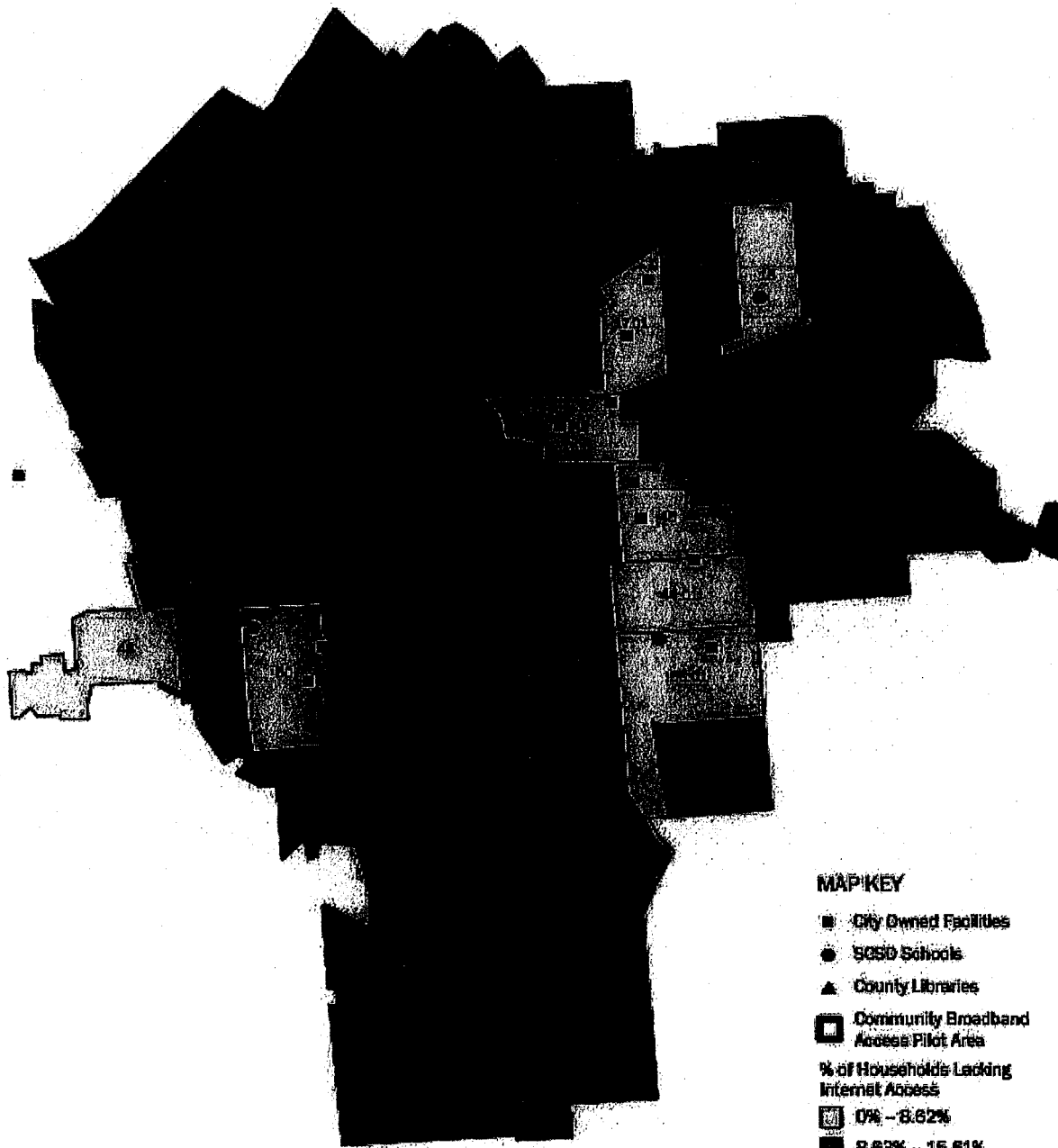
- (2) The contract shall be for a term of three (3) years and shall be effective as of the date the contract is fully executed by the City and the Consultant; and
- (3) The total cost for all services shall not exceed the \$3,500,000 in American Rescue Plan Act (ARPA) of 2021 that has been appropriated for the City of Syracuse Community Broadband Pilot Program. Payments to the Consultant shall be made in accordance with the following fee schedule:
 - Capital – One Time Network Build and Installation shall be provided at a cost not to exceed \$1,605,720.
 - Consulting Services including Education Outreach and Subscriber Enrollment shall be provided at a cost not to exceed \$257,186.
 - In the event that funding for the Affordable Connectivity Program, which currently provides a Federal Subsidy of \$30.00 per month for internet service for lower income families and is anticipated to run out of funding by Spring 2024, is not renewed or replaced by a similar Federal Subsidy Program, the Consultant shall charge the City a Managed Service Fee, at a total cost not to exceed \$1,637,094.

NOW, THEREFORE,

BE IT ORDAINED, that the Mayor, on behalf of the City of Syracuse, be and he hereby is authorized to execute such contract, as hereinabove stated, subject to the approval of the Corporation Counsel as to terms, form and execution; and

BE IT FURTHER ORDAINED, that all costs associated with this agreement shall be charged to the appropriate account designated by the Commissioner of Finance for the ARPA funding to be used for the Community Broadband Pilot Program which has been authorized contemporaneously with this Ordinance.

Re: Authorize Use of ARPA Funds and Contract for Community Broadband Program

Dear Ms. McBride,

I am requesting legislation for the March 13, 2023 Common Council session to appropriate American Rescue Plan funds and enter into a contract with CBN Geneva LLC d/b/a CBN-Syracuse LLC (herein referred to as the provider) to install, maintain, and operate a municipal broadband network to provide affordable internet service to low income families. The amount of this contract will not exceed \$3,500,000 of the American Rescue Plan Act of 2021 (ARPA) fund balance, available from an account to be designated by the Commissioner of Finance.

According to national experts, "digital equity" exists when all individuals and communities have the information technology capacity needed for full participation in society, democracy and the economy. Digital equity is necessary for civic and cultural participation, employment, lifelong learning, and access to essential services. A key requirement for digital equity is reliable, high speed home internet access, but unfortunately many families in Syracuse lack this utility. Based on the latest Census data, about 25% of households citywide lack high speed internet access at home. In many of the most economically disadvantaged census tracts in the city, about 33-40% do not have reliable home internet. In a post-COVID-19 world, digital connectivity is critical to achieving better educational, career, health, and social outcomes. In fact, the American Public Health Association characterizes broadband access as a "super-determinant" of health because it affects numerous other social determinants of health, such as education, employment, and healthcare access itself. A University of Chicago study demonstrates that, "one of the factors most consistently associated with a high risk of death due to COVID-19 in the US was the lack of internet access...regardless of other demographic risk factors..."

To help address the digital divide and improve digital equity, the city will partner with the provider to build a fixed wireless municipal broadband network to provide affordable internet service to low-income families in Syracuse. The internet network will be piloted in 10 census tracts facing the largest digital divide in the city (see map on the last page of this letter). The provider will also conduct marketing, enrollment, and ongoing resident support services. A breakdown of costs associated with the pilot are as follows:

On behalf of the Office of the Mayor, I am requesting legislation for the March 13, 2023 Common Council session to appropriate American Rescue Plan funds and enter into a contract with CBN Geneva LLC d/b/a CBN-Syracuse LLC (herein referred to as the provider) to install, maintain, and operate a municipal broadband network to provide affordable internet service to low income families. The amount of this contract will not exceed \$3,500,000 of the American Rescue Plan Act of 2021 (ARPA) fund balance, available from an account to be designated by the Commissioner of Finance.

According to national experts, “digital equity” exists when all individuals and communities have the information technology capacity needed for full participation in society, democracy and the economy. Digital equity is necessary for civic and cultural participation, employment, lifelong learning, and access to essential services. A key requirement for digital equity is reliable, high speed home internet access, but unfortunately many families in Syracuse lack this utility. Based on the latest Census data, about 25% of households citywide lack high speed internet access at home. In many of the most economically disadvantaged census tracts in the city, about 33-40% do not have reliable home internet. In a post-COVID-19 world, digital connectivity is critical to achieving better educational, career, health, and social outcomes. In fact, the American Public Health Association characterizes broadband access as a “super-determinant” of health because it affects numerous other social determinants of health, such as education, employment, and healthcare access itself. A University of Chicago study demonstrates that, “one of the factors most consistently associated with a high risk of death due to COVID-19 in the US was the lack of internet access...regardless of other demographic risk factors...”

To help address the digital divide and improve digital equity, the city will partner with the provider to build a fixed wireless municipal broadband network to provide affordable internet service to low-income families in Syracuse. The internet network will be piloted in 10 census tracts facing the largest digital divide in the city (see map on the last page of this letter). The provider will also conduct marketing, enrollment, and ongoing resident support services. A breakdown of costs associated with the pilot are as follows:



WHEREAS, the City is considering amendments to Chapter 14 of the Revised General Ordinances of the City of Syracuse relative to converting solid waste collection in the City to the use of City issued waste containers (the "Project") to protect the public health and welfare; and

WHEREAS, pursuant to Article 8 of the Environmental Conservation Law of the State of New York, as amended, and the regulations of the Department of Environmental Conservation of the State of New York promulgated thereunder (collectively, "SEQRA"), the City is required to make a determination with respect to the environmental impact of any "action" (as defined by SEQRA) to be taken by the City, and the conversion to City required containers for solid waste collection constitutes such an action (the "Action"); NOW, THEREFORE,

BE IT ORDAINED, that the City hereby designates itself as lead agency under SEQRA for purposes of the amending Chapter 14 of the Revised General Ordinances of the City of Syracuse (the "Project") relative to requiring City issued containers for solid waste collection; and

BE IT FURTHER ORDAINED, that the City, acting through its Department of Public Works, shall conduct an environmental review of the Project in accordance with SEQRA and notify any involved or interested agencies.

WHEREAS, the City of Syracuse, Department of Public Works (the "DPW") is requesting amendments to Chapter 14 of the Revised General Ordinances of the City of Syracuse to convert DPW's solid waste collection in the City to the use of City issued containers (the "Project"); and

WHEREAS, pursuant to Article 8 of the Environmental Conservation Law, as amended, the New York State Environmental Quality Review Act (the "SEQR Act") and the regulations adopted pursuant thereto by the Department of Environmental Conservation of the State of New York, being 6 NYCRR Part 617, as amended (the "Regulations"), the City of Syracuse (the "City") desires to comply with the SEQR Act and the Regulations with respect to the Project; and

WHEREAS, in furtherance of this objective, the DPW prepared a Short Environmental Assessment Form ("SEAF") for the Project (a copy of the SEAF is attached hereto as Appendix "A"); and

WHEREAS, the City has determined to conduct an uncoordinated review of the Project, and therefore, will proceed as if it were the only "involved agency" (as the quoted term is defined in the Regulations); and

WHEREAS, pursuant to the Regulations, the City has considered the significance of the potential environmental impacts of the Project by (a) using the criteria specified in Section 617.7 of the Regulations, and (b) examining the SEAF for the Project, together with other available

supporting information, to identify the relevant areas of environmental concern, and (c) thoroughly analyzing the identified areas of relevant environmental concern; NOW, THEREFORE,

BE IT ORDAINED, that, subject to the approval of the Mayor, this Common Council authorizes the following findings and determinations:

Based upon an examination of the SEAF and other available supporting information, and considering both the magnitude and importance of each relevant area of environmental concern, and based further upon the City's knowledge of the area surrounding the Project and such further investigation of the Project and its potential environmental impact as the City has deemed appropriate, the City makes the following findings and determinations:

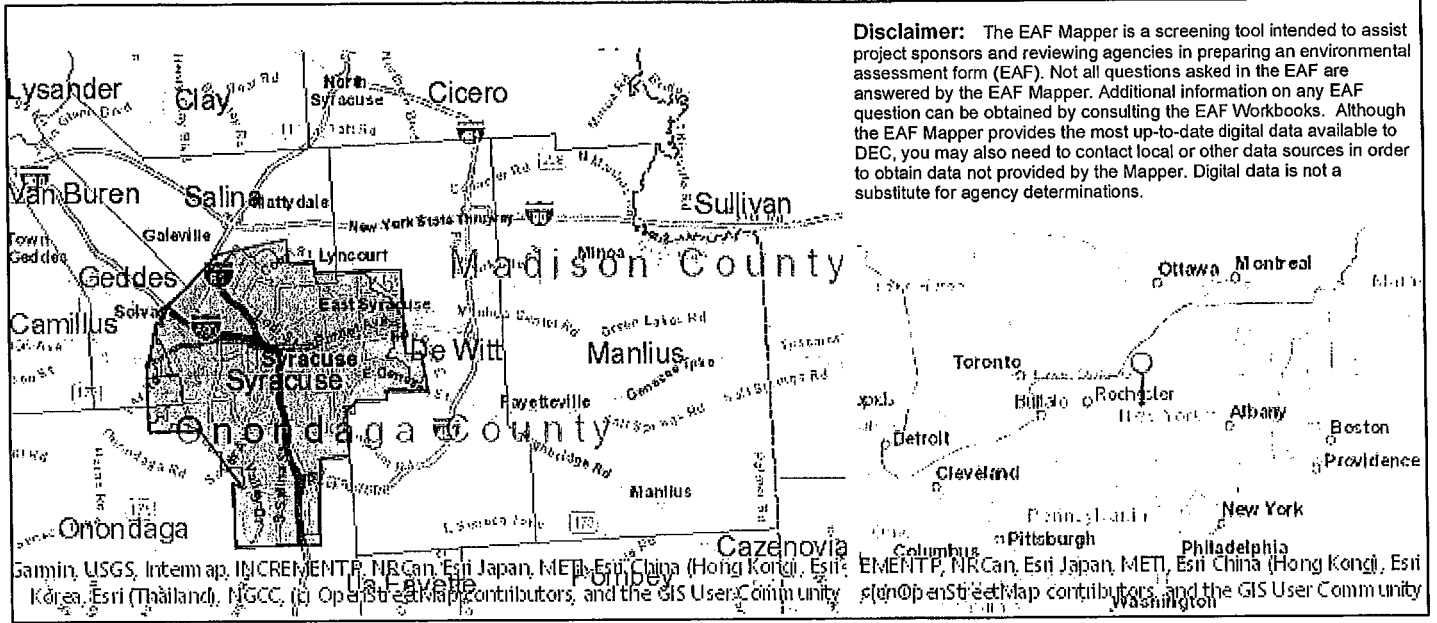

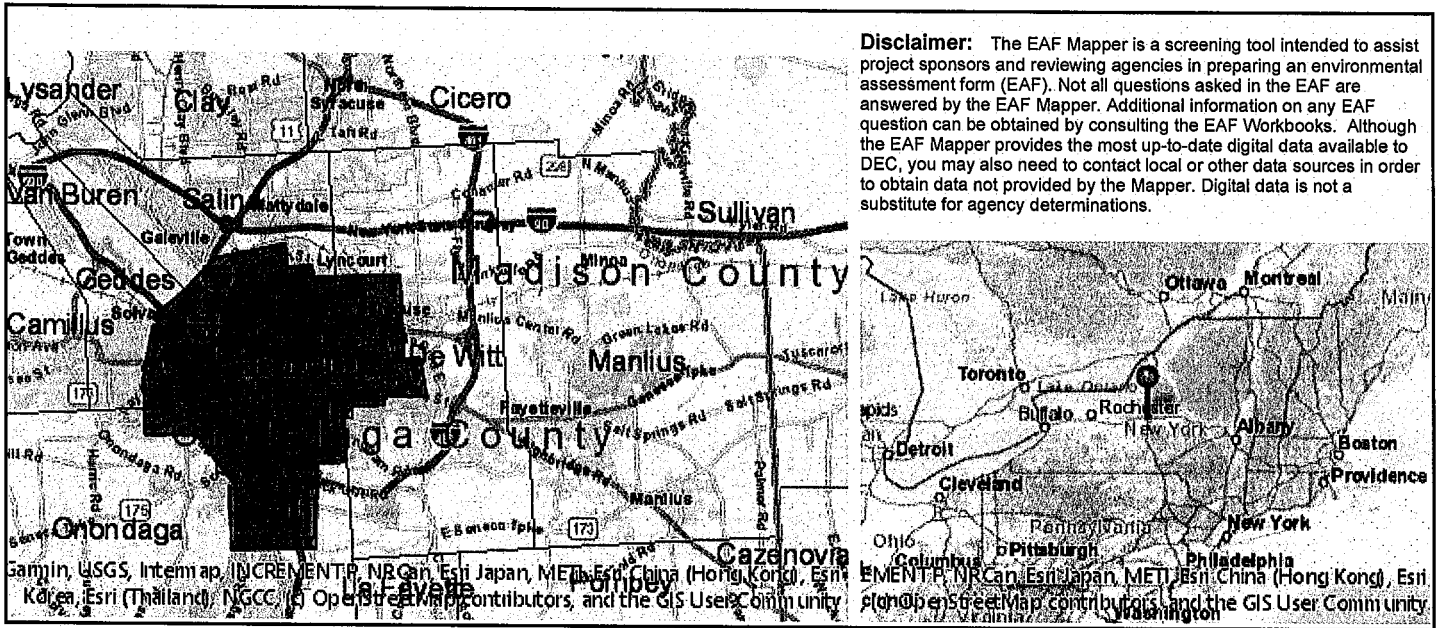

**GENERAL ORDINANCE AMENDING
CHAPTER 14 OF THE REVISED GENERAL
ORDINANCES OF THE CITY OF SYRACUSE,

COLLECTION SYSTEM FOR HOUSEHOLD
WASTE GENERATORS"**

BE IT ORDAINED, that Chapter 14 of the Revised General Ordinances of the City of Syracuse, as amended, is hereby amended to add a new Article 6 to be entitled "City of Syracuse Department of Public Works Program for Updating the City's Solid Waste and Recycling Collection System for Household Waste Generators" which shall read as follows:

Chapter 14. Health and Sanitation

Article 6. City of Syracuse Department of Public Works Program for Updating the City's Solid Waste and Recycling Collection System for Household Waste Generators

Section 14-65. Title

This Article shall be known as the "City of Syracuse Department of Public Works Program for Updating the City's Solid Waste and Recycling Collection System for Household Waste Generators".

Section 14-66. Definitions

For purposes of this Article the definitions shall be the same as those listed in Section 14-14 of this Chapter except for the following terms which for the purposes of this Article shall be defined as follows:

City Issued Regulation Container shall be defined as a 96-gallon wheeled cart owned by the City and issued by the City to residential property owners or their representatives in the City of Syracuse for the sole purpose of storage, collection and disposal of source separated solid waste.

Commissioner shall be defined as the Commissioner of the Department of Public Works.

Corporation Counsel shall be defined as the Corporation Counsel of the City of Syracuse.

Route(s) shall be defined as a route or routes selected by the Commissioner on a rolling basis to participate in the Program to update the City's Solid Waste and Recycling Collection System for Household Waste Generators.

Section 14-67. Purpose

The purpose of this Article is to authorize the Commissioner to establish a Program for updating the City's Solid Waste and Recycling Collection System for Household Waste Generators.

Section 14-68. Program to Update the City's Solid Waste and Recycling Collection System for Household Waste Generators

The Commissioner is hereby authorized to establish a Program for updating the City's Solid Waste and Recycling Collection System for Household Waste Generators.

- (a) Pursuant to this Ordinance the Department of Public Works will convert its Solid Waste Collection System for Household Waste Generators from the current system of using Regulation Containers owned and supplied by individual Household Waste Generators to a new system of using City Issued Regulation Containers. This Program will initially focus only on the Solid Waste that is not classified as Recyclable, with the intention to convert to a similar system for the collection of recyclables at a later date.
- (b) The Commissioner shall be responsible for the creation of a plan to coordinate the distribution of City Issued Regulation Containers to Household Waste Generators in the City of Syracuse.
- (c) The Commissioner will be responsible for designating the Routes for this Program. The Routes selected by the Commissioner shall be reflective of conditions across the City of Syracuse in order to collect data that will help determine how to successfully complete a City-wide conversion to City Issued Regulation Containers. Once the Program is underway the Commissioner shall determine any changes that need to be made to the initial list of designated Routes and when additional Routes will be added to the Program. The Initial Routes selected by the Commissioner shall cover various collection days in order to represent the City's normal waste collection schedule.
- (d) The Department of Public Works, pursuant to the necessary authorizations from the Mayor and the Common Council, has purchased an initial supply of City Issued Regulations Containers. As the Routes are designated by the Commissioner, the Department of Public Works will deliver a City Issued Regulation Container to Eligible Household Waste Generators on the designated Route. The selection of Routes and distribution of the City Issued Regulation Containers will be done in Phases until the Program has become City-wide.

- (e) The number of City Issued Regulation Containers provided for use by a property classified as a Household Waste Generator shall be as follows:
- Properties containing one (1) to four (4) Units, shall be issued one (1) individual City Issued Regulation Containers per unit.
 - Properties containing five (5) to ten (10) Units shall be issued a total of four (4) City Issued Regulation Containers that shall be shared by all residents of the property.
 - If a Property with five (5) to ten (10) units is unable to meet the requirements for the disposal of household waste with the four (4) City Issued Regulation Containers, then the Property Owner must arrange for private collection services as outlined for commercial waste generators in Section 14-19 of Article 2 of this Chapter.
- (f) For areas of the City that have been determined by the Commissioner to be topographically unsuitable for the use of the City Issued Regulation Containers, the Household Waste Generators will continue to use their own Regulation Containers in accordance with the requirements of Article 2 of this Chapter.
- (g) Property owners and/or their authorized representatives for non-owner occupied properties will receive notice from the Commissioner of the designation of their neighborhood as a Route participating in the program. Such notice will also provide information regarding the delivery of the City Issued Container and the date that the property owner or tenants of the residential property shall be required to cease using their current Regulation Container and begin to use the City Issued Regulation Container. The Notice will provide information on the specifics of the Program and provide contact information for questions or concerns. Individuals who require special accommodations should contact the Department of Public Works as soon as possible after receipt of the Notice.
- (h) The following Operating Rules and Regulations shall apply to the Program:
- (1) Household Waste shall be collected every seventh day in accordance with the assigned schedule for the residential neighborhood. The pickup day shall be set by the Department of Public Works. Pickup will be conducted by the Department of Public Works. Unless otherwise determined by the Commissioner, the Program shall follow the City's normal one day delay pickup schedule for the following holidays: Christmas, New Year's Day, Martin Luther King, Jr.'s Birthday; Memorial Day, Independence Day, Labor Day, and Thanksgiving Day.
 - (2) The City will provide the appropriate number of City Issued Regulation Containers for the Eligible Households located on one of the Routes participating in the Program, in accordance with subsection (e) of this Section.

- (3) The City Issued Regulation Container shall be used by the Household Waste Generator solely for storage and collection of household waste by the City of Syracuse. Other uses of the City Issued Regulation Container are prohibited.
- (4) Once the City Issued Regulation Container has been provided, this is the only container that should be used for disposal of non-recyclable solid waste at the Property. Failure to use the City Issued Regulation Container will initially result in the Commissioner or an authorized representative of the City of Syracuse, including but not limited to the Director of the City of Syracuse Division of Code Enforcement, providing a warning to the property owner that City Issued Regulation Containers must be used. Continued noncompliance with the provisions of this Article will result in the City enforcing the provisions of Section 14-70 below.
- (5) The City Issued Regulation Container shall be owned by the City but it shall be the responsibility of the property owner and all Household Waste Generators at the premises to maintain the City Issued Regulation Container in a safe and sanitary condition.
- (6) The City Issued Regulation Container must remain at the address of the residential property for which it was issued and shall be left for use by the new owner or occupant should the residential property be sold or transferred during the Program.
- (7) No City Issued Regulation Container shall be set out before 6:00 p.m. of the day preceding the scheduled pickup.
- (8) All City Issued Regulation Containers must be set out in plain view from the street and must be set adjacent to the curb line or edge of the road unless otherwise directed by the City.
- (9) All City Issued Regulation Containers must be removed from plain view from the street following collection of the household waste no later than 7:00 p.m. on the date of scheduled pickup.
- (10) With the exception of the references to Regulation Containers which are not applicable to the Routes participating in this Program, Household Waste Generators provided a City Issued Regulation Container pursuant to this Article shall continue to follow the Operating Rules and Regulations for Household Waste Generators as detailed in Section 14-18 of Article 2 of this Chapter.
- (11) No Refuse shall be placed or stored on any premises within the City except as permitted by this Chapter.
- (12) Household Waste and Refuse shall be placed in bags, deposited promptly and stored in City Issued Regulation Containers.
- (13) City Issued Regulation Containers must not be filled over their level capacity.

- (14) City Issued Regulation Containers shall be placed by the owner and/or occupant of the premises where such Refuse originated at the rear or side yard of the main building on such premises. Such Refuse shall be stored in a manner so as not to create a health hazard or public nuisance.
- (15) Any substantial accumulation of refuse or waste is hereby declared to be a sanitary health hazard and a public nuisance.
- (16) Refuse shall not be placed or stored in the street, sidewalk or gutters or in any public place except as directed herein or by the Commissioner.
- (17) The Commissioner shall have the authority to abate any sanitary health hazard or public nuisance and to impose the fees, charges and penalties of this Chapter as well as the cost of disposal for such abatement.
- (18) During the Program, circumstances may arise where it is necessary for the City Issued Regulation Container to be replaced. In such circumstances the property owner or their authorized representative shall contact the City of Syracuse Department of Public Works to request delivery of a replacement City Issued Regulation Container. Requests for replacements should be made as soon as possible so that the property can dispose of household waste on schedule. Upon enactment of this legislation the replacement City Issued Regulation Container shall be provided at no cost to the property owner; however, the Commissioner reserves the right to establish a fee schedule for replacement of City Issued Regulation Containers should such charges be deemed necessary.
- (19) Until the Commissioner has included their neighborhood as a designated Route and provided a City Issued Regulation Container, Household Waste Generators shall continue to use their own Regulation Containers and follow the Operating Rules and Regulations for Household Waste Generators as detailed in Section 14-18 of Article 2 of this Chapter.

Section 14-69. Report on the Program

The Commissioner shall provide the Mayor and the Common Council with a report detailing the data collected during the rollout of the Program following the completion of the first year of the conversion to the City Issued Regulation Containers. This report shall include any issues that were encountered during the rollout of the Program and the Commissioner's recommendations for continuation, expansion or changes to the Program. The Mayor and Common Council may request a formal report on the Program at any time during the course of the Program.

Section 14-70. Penalties and remedies for violation

(a) Except as otherwise provided herein, any person or Waste Generator who shall knowingly and willfully violate or assist in the violation of this article shall be guilty of an offense and

upon conviction shall be subject to a fine of two hundred fifty dollars (\$250.00). Each day such violation shall continue shall be deemed a separate violation subject to a separate fine.

(b) Except as otherwise provided herein, a violation of any provision of this article which shall result in the discharge or accumulation of solid waste shall be deemed a nuisance for purposes of civil remedies and shall be deemed to constitute a threat to public health and safety. Upon discovery of a discharge or accumulation of solid waste at a residential property it shall be the duty and responsibility of the Commissioner to: (i) provide notice of the condition to the Waste Generator and/or property owner where the violation has occurred by having a prominent marker placed at the site of the discharge or accumulation; (ii) mail notice of such condition to the Waste Generator and/or property owner where the violation has occurred to the address on file in the office of the department of finance, and if an address is not so filed, then notice shall be sent by certified mail to their last known address or place of residence; (iii) if the condition remains uncorrected for twenty-four (24) hours after the placement of a marker, the Commissioner shall take such actions as necessary to correct the condition, the cost of which shall be charged to the waste generator and/or property owner; (iv) a bill for the reasonable cost of the corrective action plus an administrative surcharge of the greater of one hundred dollars (\$100.00) or fifty (50) percent of the cost of the corrective action shall be delivered to the Waste Generator and/or the property owner where the violation has occurred; and the commissioner of assessment shall be authorized to add any unpaid amount of said bill to the next succeeding property tax bill as a "special solid waste charge" which shall be a lien against the property.

(c) In addition to the above-provided penalties and revocations, or in lieu thereof, the Corporation Counsel may also institute and maintain an action or proceeding in the name of the City of Syracuse in a court of competent jurisdiction to compel compliance with or to restrain by temporary restraining order, preliminary and/or permanent injunction, any violation of this ordinance.

; and

BE IT FURTHER ORDAINED, that these amendments to Chapter 14 of the Revised General Ordinances of the City of Syracuse, as amended, shall be effective immediately, provided that those provisions of Chapter 14 of the Revised General Ordinances of the City of Syracuse, as amended, which are unchanged by these amendments shall remain in full force and effect and shall be regarded for all purposes as having been in effect continuously and any new provisions shall be applied prospectively.

Dear Ms. McBride:

Please prepare legislation for the next regular meeting of the Common Council to amend Article 2 of Chapter 14 of the Revised General Ordinances entitled "Solid Waste Collection and Disposal" to authorize the Commissioner to establish a Program for updating the City's Solid Waste and Recycling Collection System for Household Waste Generators.

The amended General Ordinance will add new sections to facilitate the rollout of the new residential cart program for waste collection. Specifically, these sections will deal with:

(a) Converting DPW's Solid Waste Collection System for Household Waste Generators from the current system of using Regulation Containers owned and supplied by residential property owners to a new system of using City Issued Regulation Containers. This Program will initially focus only on the Solid Waste that is not classified as Recyclable, with the intention to convert to a similar system for the collection of recyclables at a later date.

(b) The Commissioner shall be responsible for the creation of a plan to coordinate the distribution of City Issued Regulation Containers to Household Waste Generators in the City of Syracuse.

(c) The Commissioner will be responsible for designating the Routes for this Program. The Commissioner will designate at least five (5) Routes for participation in the initial rollout of the Program. The Routes selected by the Commissioner shall be reflective of conditions across the City of Syracuse in order to collect data that will help determine how to successfully complete a City-wide conversion to City Issued Regulation Containers. Once the Program is underway the Commissioner shall determine any changes that need to be made to the initial list of designated


Routes and when additional Routes will be added to the Program. The Initial Routes selected by the Commissioner shall cover various collection days in order to represent the City's normal waste collection schedule.

- (d) The Department of Public Works, pursuant to the necessary authorizations from the Mayor and the Common Council, has purchased an initial supply of City Issued Regulations Containers. As the Routes are designated by the Commissioner, the Department of Public Works will deliver a City Issued Regulation Container to each residential property on the designated Route. The selection of Routes and distribution of the City Issued Regulation Containers will be done in Phases until the Program has become City-wide.
- (e) For areas of the City that have been determined by the Commissioner to be topographically unsuitable for the use of the City Issued Regulation Containers, the Household Waste Generators will continue to use their own Regulation Containers in accordance with the requirements of Article 2 of this Chapter.
- (f) Property owners and/or their authorized representatives for non-owner occupied properties will receive notice of the designation of their neighborhood as a Route participating in the program. Such notice will also provide information regarding the delivery of the City Issued Container and the date that the property owner or tenants of the residential property shall be required to cease using their current Regulation Container and begin to use the City Issued Regulation Container. The Notice will provide information on the specifics of the Program and provide contact information for questions or concerns. Individuals who require special accommodations should contact the Department of Public Works as soon as possible after receipt of the Notice.

Existing sections and definitions of the current Solid Waste Ordinance will continue to apply to those neighborhoods where the rollout has not occurred.

BOND ORDINANCE OF THE CITY OF SYRACUSE AUTHORIZING THE ISSUANCE AND SALE OF BONDS IN THE AMOUNT OF ONE MILLION NINE HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$1,925,000.00) TO DEFRAY THE COST AND EXPENSE OF THE 2023/2024 DEPARTMENT OF PUBLIC WORKS CAPITAL EQUIPMENT & VEHICLES PROGRAM

BE IT ORDAINED, by the Common Council of the City of Syracuse as follows:

Section 1. For the specific object or purpose of providing funds to defray the cost and expense of the purchase of two (2) Auto Lifts, seventy-two (72) Radios, three (3) Floor Jacks, two (2) Roll Off Trucks, one (1) Four-Door Crew Cab Packer Truck, twenty (20) Tippers, one (1) Mini Dump Truck, one (1) Bucket Truck, Ten (10) Pickup Trucks and six (6) small SUVs (City Hall) for the Department of Public Works as part of the 2023/2024 Department of Public Works Capital Equipment & Vehicles Program, at a cost not to exceed One Million Nine Hundred Twenty-Five Thousand Dollars (\$1,925,000.00), general obligation bonds of the City of Syracuse, to be of the terms, form and contents hereinafter provided for, are hereby authorized to be issued pursuant to the provisions of the Local Finance Law of the State of New York.

Section 2. One Million Nine Hundred Twenty-Five Thousand Dollars (\$1,925,000.00) is estimated as the maximum cost of the specific object or purpose for which such bonds are to be issued.

Section 3. The plan for financing such specific object or purpose consists of the issuance and sale of bonds of the City of Syracuse in the principal sum of One Million Nine Hundred Twenty-Five Thousand Dollars (\$1,925,000.00), thereby providing such sum for all the maximum cost of such specific object or purpose.

Section 4. It is hereby determined that the specific object or purpose for which bonds are to

be issued falls within subdivision 32 of paragraph (a) Section 11.00 of the Local Finance Law and the period of probable usefulness of such specific object or purpose is five (5) years.

Section 5. The Commissioner of Finance, not more than fifteen (15) days and not less than three (3) days before the sale of said bonds, shall file with the Comptroller of the State of New York a supplemental debt statement and file a duplicate thereof with the City Clerk in compliance with Section 109.00 of the Local Finance Law.

Section 6. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell the bonds and bond anticipation notes in anticipation of the issuance and sale of the bonds herein authorized, including renewals of such notes, is hereby delegated to the Commissioner of Finance who is the chief fiscal officer of the City under the Local Finance Law. The Commissioner of Finance may sell such bonds at public or private sale, with or without bond insurance or other credit enhancement, at a discount or premium, at fixed or variable rates of interest or at no interest whatsoever, or as capital appreciation bonds, and with such amortization of principal as the Commissioner of Finance shall determine is most favorable to said City, and in compliance with any rules of the State Comptroller applicable thereto. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Commissioner of Finance, consistent with the provisions of the Local Finance Law. The Commissioner of Finance is hereby authorized to issue variable rate debt, acquire credit support, and enter into such agreements as said officer finds reasonable to facilitate the issuance, sale, resale and repurchase of such bonds, as authorized under Sections 54.90 and 168.00 of the Local Finance Law. Said bonds shall be signed in the name of the City by the original or facsimile signature of the Mayor and countersigned by the original or facsimile signature of the Commissioner of Finance and sealed with the original or facsimile corporate seal of the City, provided, however, that if the signatures of the Mayor and the

Commissioner of Finance are each by facsimile signatures on any bond, such bond shall be authenticated by the manual countersignature of a fiscal agent of the City. All other matters, except as provided herein, relating to such bonds, including prescribing whether manual or facsimile signatures shall appear on said bonds, prescribing the method for the recording of ownership of said bonds, appointing the fiscal agent or agents for said bonds, providing for the printing and delivery of said bonds (and if said bonds are to be executed in the name of the City by only facsimile signatures, providing for the manual countersignature of a fiscal agent or of a designated official of the City), the date, form, denominations, maturities, interest rate or rates, terms of and manner of sale and interest payment dates, place or places of payment, and also including the consolidation with other issues, shall be determined by the Commissioner of Finance. The Commissioner of Finance may elect to become the fiscal agent for the bonds, or may contract on behalf of the City for this service pursuant to the Local Finance Law. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law and shall otherwise be in such form and contain such recitals in addition to those required by Section 52.00 of the Local Finance Law, as the Commissioner of Finance shall determine. The Commissioner of Finance may also agree on behalf of the City to provide or disclose such information about the City as may be necessary to enable the purchasers of bonds or notes of the City to comply with Securities and Exchange Commission Rule 15c2-12.

Section 7. The temporary use of available funds of the City of Syracuse, not immediately required for the purpose or purposes for which the same were raised or otherwise created, is hereby authorized pursuant to Section 165.10 of the Local Finance Law, for the capital purposes described in Section 1 of this ordinance. The reasonably expected source of funds to be used to initially pay for the expenditures authorized by Section 1 of this resolution shall be from the City's Capital

Fund. It is intended that the City shall then reimburse expenditures from the Capital Fund with the proceeds of the bonds and bond anticipation notes authorized by this ordinance and that the interest payable on the bonds and any bond anticipation notes issued in anticipation of such bonds shall be excludable from gross income for federal income tax purposes. This ordinance is intended to constitute the declaration of the City's "official intent" within the meaning of Treasury Regulation Section 1.150-2 to reimburse the expenditures authorized by this ordinance with the proceeds of the bonds and bond anticipation notes authorized herein. Other than as specified in this ordinance, no monies are reasonably expected to be received, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the objects or purposes described herein.

Section 8. When said bonds and notes shall have been duly sold, the same shall be delivered by the Commissioner of Finance to the purchaser upon payment to him of the purchase price, including accrued interest, and the receipt of the Commissioner of Finance shall be a full acquittance to such purchaser who shall not be obliged to see to the application of the purchase money.

Section 9. The faith and credit of the City of Syracuse are hereby pledged to the payment of the principal of said bonds and interest thereon when due. An amount sufficient to pay the principal and interest on said bonds as the same becomes due each year shall be included in the annual budget of said City for the year.

Section 10. The validity of the bonds hereby authorized may be contested only if such obligations are authorized for an object or purpose for which the City of Syracuse is not authorized to expend money, or the provisions of law which should be complied with at the date of the publication of this ordinance are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication, or such

obligations are authorized in violation of the provisions of the Constitution.

Section 11. This ordinance shall take effect immediately.







WHEREAS, the City of Syracuse, Department of Engineering (the "DOE") intends to implement the Cold Brook Improvements Project (the "Project"); and

WHEREAS, the scope of the Project is to improve the channel conditions between the City Line (Edna Rd. approximately) and the outfall at Onondaga Creek; and

WHEREAS, the improvements will consist of sediment removal, vegetation clearing and grubbing, channel wall repairs and other associated work; and

WHEREAS, pursuant to Article 8 of the Environmental Conservation Law, as amended, the New York State Environmental Quality Review Act (the "SEQR Act") and the regulations adopted pursuant thereto by the Department of Environmental Conservation of the State of New York, being 6 NYCRR Part 617, as amended (the "Regulations"), the City of Syracuse (the "City") desires to comply with the SEQR Act and the Regulations with respect to the Project; and

WHEREAS, pursuant to the Regulations, the City has considered the significance of the potential environmental impacts of the Project by (a) using the criteria specified in Section 617.5 (replacement rehabilitation or reconstruction of a structure or facility, in kind, on the same site) of the Regulations; NOW, THEREFORE,

BE IT ORDAINED, that, subject to the approval of the Mayor, this Common Council authorizes the following findings and determinations:

Based upon an examination of the Regulations and other available supporting information, and considering both the magnitude and importance of each relevant area of environmental

concern, and based further upon the City's knowledge of the area surrounding the Project and such further investigation of the Project and its potential environmental impact as the City has deemed appropriate, the City makes the following findings and determinations:

- (1) The Project constitutes a "Type II Action" (as the quoted term is defined in the Regulations); and
- (2) Therefore, the City hereby determines that the Project will not have a significant adverse environmental impact, and the City will not require the preparation of an environmental impact statement with respect to the Project; and

BE IT FURTHER ORDAINED, that as a consequence of such determination and in compliance with the requirements of the SEQR Act and the Regulations, the City directs the City Engineer to prepare any necessary Type II SEQRA documents; and

BE IT FURTHER ORDAINED, that the SEQRA documents for the Project be filed in accordance with the Regulations; and

BE IT FURTHER ORDAINED, that the City Engineer is authorized to take whatever steps are necessary to carry out this Ordinance; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect immediately.

BOND ORDINANCE OF THE CITY OF SYRACUSE AUTHORIZING THE ISSUANCE AND SALE OF BONDS IN THE AMOUNT OF EIGHT HUNDRED THOUSAND DOLLARS (\$800,000.00) TO DEFRAY THE COST AND EXPENSE OF THE 2023/2024 COLD BROOK IMPROVEMENTS PROJECT TO IMPROVE THE CHANNEL CONDITIONS BETWEEN THE CITY LINE (EDNA ROAD APPROX.) AND THE OUTFALL AT ONONDAGA CREEK

BE IT ORDAINED, by the Common Council of the City of Syracuse as follows:

Section 1. For the specific object or purpose of providing funds to defray the cost and expense of the 2023/2024 Cold Brook Improvements Project to make improvements consisting of sediment removal, vegetation clearing and grubbing, channel wall repairs and other associated work consistent with open channel repairs, in an effort to improve the channel conditions between the City Line (Edna Road approx.) and the outfall at Onondaga Creek, at a cost not to exceed Eight Hundred Thousand Dollars (\$800,000.00), general obligation bonds of the City of Syracuse, to be of the terms, form and contents hereinafter provided for, are hereby authorized to be issued pursuant to the provisions of the Local Finance Law of the State of New York.

Section 2. Eight Hundred Thousand Dollars (\$800,000.00) is estimated as the maximum cost of the specific object or purpose for which such bonds are to be issued.

Section 3. The plan for financing such specific object or purpose consists of the issuance and sale of bonds of the City of Syracuse in the principal sum of Eight Hundred Thousand Dollars (\$800,000.00), thereby providing such sum for all the maximum cost of such specific object or purpose.

Section 4. It is hereby determined that the specific object or purpose for which bonds are to

be issued falls within subdivision 3 of paragraph (a) Section 11.00 of the Local Finance Law and the period of probable usefulness of such specific object or purpose is ten (10) years.

Section 5. The Commissioner of Finance, not more than fifteen (15) days and not less than three (3) days before the sale of said bonds, shall file with the Comptroller of the State of New York a supplemental debt statement and file a duplicate thereof with the City Clerk in compliance with Section 109.00 of the Local Finance Law.

Section 6. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell the bonds and bond anticipation notes in anticipation of the issuance and sale of the bonds herein authorized, including renewals of such notes, is hereby delegated to the Commissioner of Finance who is the chief fiscal officer of the City under the Local Finance Law. The Commissioner of Finance may sell such bonds at public or private sale, with or without bond insurance or other credit enhancement, at a discount or premium, at fixed or variable rates of interest or at no interest whatsoever, or as capital appreciation bonds, and with such amortization of principal as the Commissioner of Finance shall determine is most favorable to said City, and in compliance with any rules of the State Comptroller applicable thereto. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Commissioner of Finance, consistent with the provisions of the Local Finance Law. The Commissioner of Finance is hereby authorized to issue variable rate debt, acquire credit support, and enter into such agreements as said officer finds reasonable to facilitate the issuance, sale, resale and repurchase of such bonds, as authorized under Sections 54.90 and 168.00 of the Local Finance Law. Said bonds shall be signed in the name of the City by the original or facsimile signature of the Mayor and countersigned by the original or facsimile signature of the Commissioner of Finance and sealed with the original or facsimile corporate seal of the City, provided, however, that if the signatures of the Mayor and the

Commissioner of Finance are each by facsimile signatures on any bond, such bond shall be authenticated by the manual countersignature of a fiscal agent of the City. All other matters, except as provided herein, relating to such bonds, including prescribing whether manual or facsimile signatures shall appear on said bonds, prescribing the method for the recording of ownership of said bonds, appointing the fiscal agent or agents for said bonds, providing for the printing and delivery of said bonds (and if said bonds are to be executed in the name of the City by only facsimile signatures, providing for the manual countersignature of a fiscal agent or of a designated official of the City), the date, form, denominations, maturities, interest rate or rates, terms of and manner of sale and interest payment dates, place or places of payment, and also including the consolidation with other issues, shall be determined by the Commissioner of Finance. The Commissioner of Finance may elect to become the fiscal agent for the bonds or may contract on behalf of the City for this service pursuant to the Local Finance Law. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law and shall otherwise be in such form and contain such recitals in addition to those required by Section 52.00 of the Local Finance Law, as the Commissioner of Finance shall determine. The Commissioner of Finance may also agree on behalf of the City to provide or disclose such information about the City as may be necessary to enable the purchasers of bonds or notes of the City to comply with Securities and Exchange Commission Rule 15c2-12.

Section 7. The temporary use of available funds of the City of Syracuse, not immediately required for the purpose or purposes for which the same were raised or otherwise created, is hereby authorized pursuant to Section 165.10 of the Local Finance Law, for the capital purposes described in Section 1 of this ordinance. The reasonably expected source of funds to be used to initially pay for the expenditures authorized by Section 1 of this resolution shall be from the City's Capital

Fund. It is intended that the City shall then reimburse expenditures from the Capital Fund with the proceeds of the bonds and bond anticipation notes authorized by this ordinance and that the interest payable on the bonds and any bond anticipation notes issued in anticipation of such bonds shall be excludable from gross income for federal income tax purposes. This ordinance is intended to constitute the declaration of the City's "official intent" within the meaning of Treasury Regulation Section 1.150-2 to reimburse the expenditures authorized by this ordinance with the proceeds of the bonds and bond anticipation notes authorized herein. Other than as specified in this ordinance, no monies are reasonably expected to be received, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the objects or purposes described herein.

Section 8. When said bonds and notes shall have been duly sold, the same shall be delivered by the Commissioner of Finance to the purchaser upon payment to him of the purchase price, including accrued interest, and the receipt of the Commissioner of Finance shall be a full acquittance to such purchaser who shall not be obliged to see to the application of the purchase money.

Section 9. The faith and credit of the City of Syracuse are hereby pledged to the payment of the principal of said bonds and interest thereon when due. An amount sufficient to pay the principal and interest on said bonds as the same becomes due each year shall be included in the annual budget of said City for the year.

Section 10. The validity of the bonds hereby authorized may be contested only if such obligations are authorized for an object or purpose for which the City of Syracuse is not authorized to expend money, or the provisions of law which should be complied with at the date of the publication of this ordinance are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication, or such

obligations are authorized in violation of the provisions of the Constitution.

Section 11. This ordinance shall take effect immediately.

WHEREAS, the City Engineer has requested legislation authorizing the City to apply for and enter into an agreement with the New York State Canal Corporation relative to a use and occupancy permit to be issued to the City to use the State owned property along the Barge Canal in the Syracuse Inner Harbor for operation of a kayak/canoe launch as shown in the plan attached hereto as Exhibit “A”; NOW, THEREFORE,

BE IT ORDAINED, subject to the approval of the Mayor, that the City Engineer be and she is hereby authorized to submit an application for a use and occupancy permit, having a fee not to exceed \$50.00*; and

BE IT FURTHER ORDAINED, that upon approval of said application that the Mayor be and he is hereby authorized to enter into an agreement with the New York Canal Corporation relative to a use and occupancy permit for the State owned property along the Barge Canal in the Syracuse Inner Harbor for operation of a kayak/canoe launch, as shown in the plan attached to this Ordinance as Exhibit “A”; and

BE IT FURTHER ORDAINED, that all costs associated with the application and agreement shall be charged to the Department of Engineering Operating Budget Account # 80400.01.540552 or another appropriate account as designated by the Commissioner of Finance; and

BE IT FURTHER ORDAINED, that the agreement shall contain language that the City shall provide the New York State Canal Corporation with a letter confirming the City's self-insured status to meet the general liability insurance requirements of the use and occupancy permit which shall provide protection for the State of New York and the City against any claims, suits, demands or judgments by reason of bodily injury, including death, and confirms that pursuant to the requirements of the use and occupancy permit the People of the State of New York, the New York State Canal Corporation, and the New York State Power Authority shall be considered to be an additional insured party; and

BE IT FURTHER ORDAINED, that the agreement shall contain language that the City will furnish the State with thirty (30) days prior written notice of any major change in the City's self-insured status; and

BE IT FURTHER ORDAINED, that said agreement shall contain such other terms and conditions as the Corporation Counsel shall deem in the best interest of the City of Syracuse; and

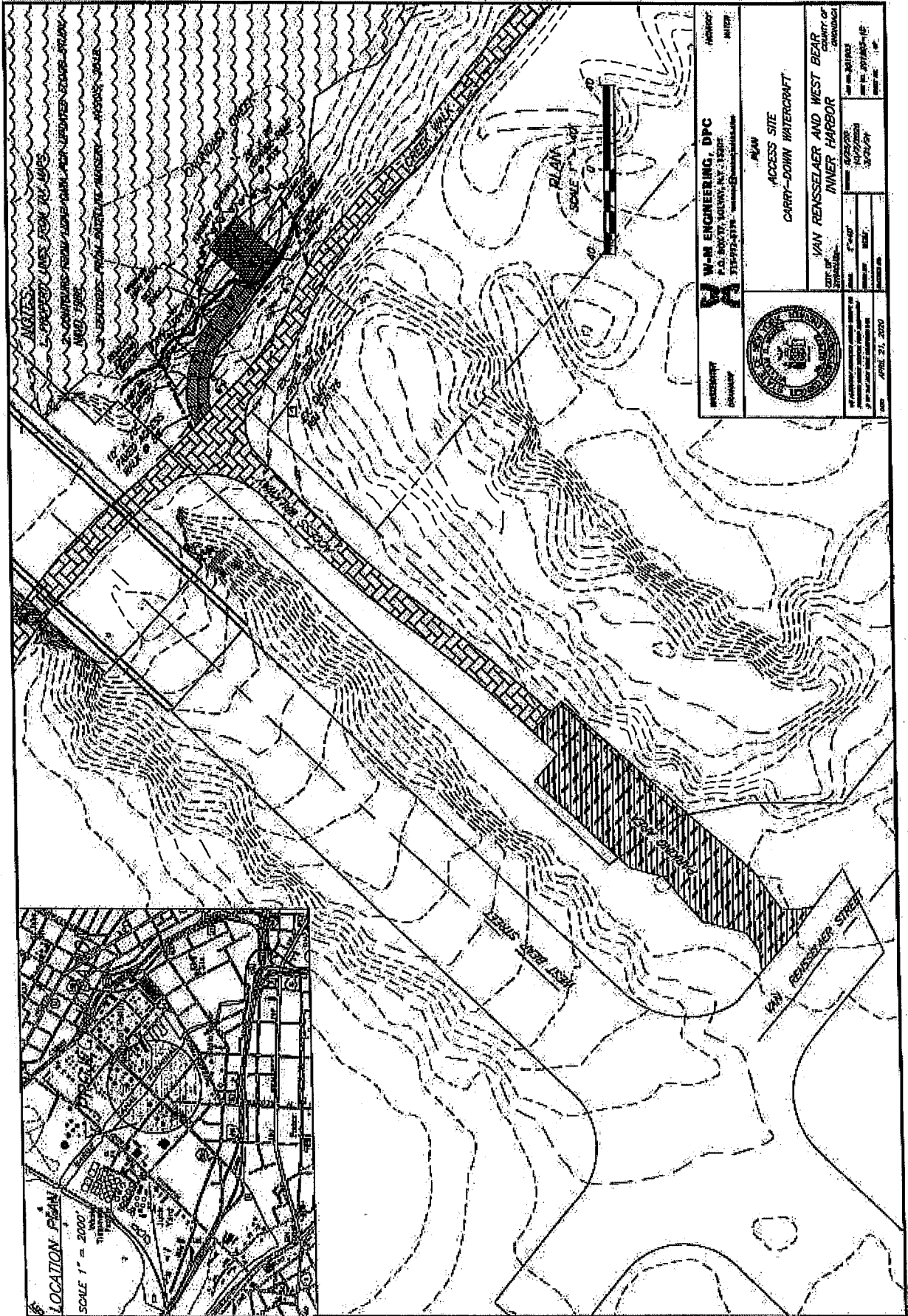

WHEREAS, Ordinance No. 295-2022 appropriated \$11,000,000.00 of the American Rescue Plan Act of 2021 (ARPA) Funds received by the City of Syracuse to an account to be used by the Department of Neighborhood and Business Development (“NBD”) to fund Infill Housing Construction to support the cost of new construction or rehabilitation of single-family owner-occupied units for income qualified first-time homebuyers and develop scattered-site two-family rental units; and

WHEREAS, pursuant to Ordinance No. 295-2022, NBD issued Request for Qualifications (“RFQ”) #23-007 to identify agencies qualified to support the new construction or rehabilitation of single-family owner occupied units for income-eligible first time homebuyers (“Infill Housing Projects”) and develop scattered-site two-family rental units; and

WHEREAS, Ordinance No. 467-2022, as amended by Ordinance No. 842-2022, authorized the Commissioner of NBD to select from the list of eleven (11) agencies identified by the RFQ as eligible to perform Infill Housing Projects, subject to the approval of the Common Council as to specific projects and contracts; and

WHEREAS, the Commissioner of NBD has approved Home Headquarters, Inc. to construct five (5) single family homes at 207 Ontario Street, 622 Otisco Street, 625 Otisco Street, 626A Otisco Street, and 626B Otisco (hereinafter referred to as the “Project”) under the following terms:

- (4) Home Headquarters, Inc. shall provide all required services necessary for the Project in a manner consistent with RFQ #23-007; and
- (5) The total cost for all services shall not exceed \$500,000.00 in American Rescue Plan Act of 2021 (ARPA) funds appropriated by the City by Ordinance No. 295-2022;

NOW, THEREFORE,

BE IT ORDAINED, that the Commissioner of the Department of Neighborhood & Business Development, on behalf of the City of Syracuse, be and he hereby is authorized to execute all necessary agreements as to this Project, as hereinabove stated, subject to the approval of the Corporation Counsel as to terms, form and execution; and

BE IT FURTHER ORDAINED, that all costs associated with this agreement shall be charged to the appropriate account designated by the Commissioner of Finance for the ARPA funding to be used for the Project which has been authorized by Ordinance No. 295-2022.

BE IT ORDAINED, that the following resolution adopted by the City Planning Commission of the City of Syracuse on February 21, 2023, pursuant to Article V, Chapter 13, of the Charter of the City of Syracuse-1960, as amended, approving the application of Jamar Clarke, applicant, and Ron Koretz of BVK Syracuse Prop Owner, LLC, owner, for a special permit for indoor amusement and recreation to establish a fitness center on property situated at 919 East Genesee Street, Syracuse, New York, pursuant to Part B, Section III, Article 2, and Part C, Section IV, Articles 1 and 1 of the Zoning Rules and Regulations of the City of Syracuse, as amended, in the manner and upon the conditions stated, be and the same hereby is consented to and approved, namely:

We, the duly appointed members of the City Planning Commission of the City of Syracuse, do this 21st day of February, 2023, adopt the following resolution:

- WHEREAS, the applicant, Jamar Clarke, is requesting a Special Permit for Indoor Amusement and Recreation in order to establish a fitness center on property situated at 919 East Genesee Street pursuant to Part B, Section III, Article 2 and Part C, Section IV, Articles 1 and 2 of the City of Syracuse Zoning Rules and Regulations, as amended; and
- WHEREAS, the City Planning Commission held a Public Hearing on the request on February 21, 2023, at 6:00 p.m. in the Common Council Chambers, City Hall, Syracuse, New York, heard all those desiring to be heard, and duly recorded their testimony; and
- WHEREAS, the City Planning Commission has studied the proposal and all submittals by the applicant and all interested parties; and
- WHEREAS, the scope of work includes interior renovations to an area on the north end of the first floor that had previously been identified as retail space, and exterior renovations to the north and east elevations at the corner of East Fayette Street and South Crouse Avenue that include installing two eight-square foot wall signs and accessory neon-like, LED lighting; and
- WHEREAS, the subject property is irregular in shape with approximately 90 feet of frontage on East Fayette Street, 506.23 feet of frontage on South Crouse Avenue, 155.32 feet of frontage on East Genesee Street, and 240.42 feet of frontage on Irving Avenue; and
- WHEREAS, the property lies within a Business, Class A zoning district, as do the adjacent and neighboring properties to the north, south, east, and west; and
- WHEREAS, land use in the area consists primarily of office, commercial, and retail uses; the Syracuse University Planned Institutional District lies to the south; and
- WHEREAS, the "Syracuse Land Use and Development Plan" designates the character of this site, which lies in the Eastside neighborhood, as Urban Core; and
- WHEREAS, the City Planning Commission approved a Project Site Review (PR-16-36) on November 14, 2016, to construct a seven-story, 245-unit apartment building with retail space, with subsequent modifications thereto on March 20 and May 22, 2017 (PR-16-36M1 and M2, respectively); and
- WHEREAS, the City Planning Commission approved a companion Resubdivision (R-16-44) on November 14, 2016, to combine seven properties into one new Lot; and

- WHEREAS, the City Planning Commission approved a Special Permit for a Restaurant (SP-20-01) on January 13, 2020, granting four waivers from the City of Syracuse Zoning Rules and Regulations, as amended, with respect to the off-street parking, sign quantity, street line treatment area, and arterial setback regulations; and
- WHEREAS, land uses on the site include 245 dwelling units with resident amenities on the first floor, a restaurant (Taichi Bubble Tea), and the proposed fitness center (Drip Fitness); and
- WHEREAS, the hours of operation for the proposed fitness center will be from 5:00 a.m. until 8:00 p.m. Sunday through Saturday, with a maximum of 4 employees on premises at one time; and
- WHEREAS, the applicant is proposing to install two, back lit, eight-square foot wall signs with neon-like LED accessory lighting facing East Fayette Street and South Crouse Avenue; and
- WHEREAS, the applicant did not submit a site plan as there are no proposed site alterations to the site plan previously approved by the Planning Commission as part of the approved Project Site Review (PR-16-36); and
- WHEREAS, the applicant submitted floor plans (Sheets G0.02, G0.03, and A1.00) dated September 19, 2022, which illustrate the proposed fitness center situated at the north end of the first floor at the corner of East Fayette Street and South Crouse Avenue with approximately 1,760 square feet of floor space arranged, intended, or designed for fitness purposes; and
- WHEREAS, the applicant submitted an elevation plan (Sheet A2.00) dated September 19, 2022, which illustrates the dimensions and locations of the two proposed wall signs with four neon-like LED accessory lighting strips facing South Crouse Avenue and two similar accessory lighting strips facing East Fayette Street; and
- WHEREAS, existing and proposed land uses on the property necessitate 347 off-street parking spaces; the site has 253 parking spaces available, a shortage of 94 spaces; the City Planning Commission waived 86 spaces as part of SP-20-01; there remains a shortage of eight spaces; and
- WHEREAS, the proposal deviates from Part C, Section III, Article 1 of the City of Syracuse Zoning Rules and Regulations, as amended, in that the proposed fitness center requires 18 off-street parking spaces and the site only has ten spaces available; the proposal requires an expanded parking waiver of eight off-street parking spaces from the 86 spaces previously waived by the City Planning Commission on January 13, 2020 (SP-20-01), for a total waiver of 94 off-street parking spaces; and
- WHEREAS, the proposal deviates from Part C, Section VI, Article 14 of the City of Syracuse Zoning Rules and Regulations, as amended, in that Special Permit Uses are allowed one wall sign and one ground sign, neither to exceed 40 square feet; the applicant is proposing to install two wall signs; and

WHEREAS, the proposal necessitates two waivers from the City of Syracuse Zoning Rules and Regulations, as amended, with respect to the parking and sign regulations; and

WHEREAS, the proposal was submitted to the City of Syracuse Departments of Engineering and Public Works for review; and

WHEREAS, the proposal was reviewed by the Onondaga County Planning Board pursuant to GML §239-1, m and n; and

WHEREAS, due consideration was given to the necessity, adequacy, and character of the proposed development, and vehicular and pedestrian circulation within the immediate vicinity; and

WHEREAS, the proposed use is so located as not to be detrimental to adjoining zoning districts and permitted uses; and

WHEREAS, the proposed use will not create hazardous or obnoxious conditions, and the public health, welfare, and safety will be protected; and

WHEREAS, the proposal was found to be in character with the adjoining land use;

WHEREAS, pursuant to Article 8 of the State Environmental Conservation Law, as amended and the regulations promulgated thereunder (collectively "SEQRA"), the Commission is required to make a determination with respect to the environmental impact of any "action" (as defined by SEQRA) to be taken by the Commission and the consideration of the Application constitutes such an action; and

WHEREAS, the Commission reviewed the Application and the Environmental Assessment Form dated September 28, 2022 ("EAF") prepared by the applicant, and determined that the proposed action described therein constituted an "Unlisted" action (as said quoted terms is defined in SEQRA); and

WHEREAS, the Commission declares itself "Lead Agency" (as said quoted term is defined in SEQRA) with respect to an uncoordinated review pursuant to SEQRA; and finds that approval of the Application as set forth herein will not have a significant effect on the environment, and the Commission hereby issues a negative declaration pursuant to SEQRA, a copy of which is attached hereto as Exhibit "A", which shall be filed in the office of the Commission.

NOW THEREFORE BE IT RESOLVED that We, the duly appointed members of the City Planning Commission of the City of Syracuse, do this 21st day of February, 2023, APPROVE the request of Jamar Clarke for a Special Permit for Indoor Amusement and Recreation in order to establish a fitness center on property situated at 919 East Genesee Street pursuant to Part B, Section III, Article 2 and Part C, Section IV, Articles 1 and 2 of the City of Syracuse Zoning Rules and Regulations, as amended;

BE IT FURTHER RESOLVED that said application be approved subject to compliance with the following conditions:

1. The subject premises shall be used, operated and maintained in a neat and orderly condition at all times; all outside storage of junk, bottles, cartons, boxes, debris and the like shall be restricted to appropriately screened enclosures not visible to the general public;
