Meeting Notes:

- Chief Cecile: Stated that Section 1.B is opposed to both a CRB city ordinance and also NYS Discovery Laws.
- Patrick Blood: Stated that if individuals FOILed their own information, we would probably have to provide it, unless there is an active law investigation.
- Jennifer Tifft stated: We can add to the stipulations the uses required by CRB & NYS Discovery
- The team discussed adding a note that if documents become a part of an investigation, that this will be able to be kept longer. • Patrick Blood asked why we are requesting 14 days, when there is a different number for COPS Cameras.
- Chief Cecile stated that COPS Camera's were heldfor 14 days, but DA's and prosecuter's requested this for longer, and they currently hold this for 30 days.
- Daniel Schwarz stated that Flock Safety keeps track of the amount of scans that they provide. Daniel asked if the offer from Flock Safety includes us having to share our data with Flock Safety.
- Chief Cecile stated that it is his understanding that in Evidence.com, Chief Cecile stated that he can limit the amount of data that is shared with Flock Safety.
- Michelle S. asked about the process for police officers to access COPS Camera's and potentially LPR Reader Data.
- Chief Cecile explained that the Officer's have to document the DR Number for the case when they are accessing COPS Camera footage.
- A vote regarding the ALPR Technology and the Proposed Guidelines was held.
