Meeting called to order at 1:05 p.m. by Mr. Koenig.

A motion was made to approve by Mr. Cheslik and seconded by Mr. Koenig to adopt the minutes from the July 11, 2019 meeting. Motion carried unanimously.

Elmcrest Children's Center / City of Syracuse / Christopher Community (Applicants)

A Use Variance request to construct 50 dwelling units comprised of 16 buildings, and one community center building, waiving the uses permitted in a Residential, Class A-1, pursuant to Part B, Section I, Article 1.

Mr. Koenig recused himself from the proceedings as one of the applicants, Christopher Community, Inc., is a business client. Mr. Stanton assumed the duties of the board chair. Ms. Ryan, legal counsel to the Board, explained that the three remaining voting members participating in the meeting did not meet a voting quorum (four voting members) and, therefore, the Board could not take any action. As a result, the public hearing would be held open until the next meeting. Public comments made at this hearing would be recorded. Commenters were encouraged to return and provide comment at the next Board meeting, so that the Board members not present today could hear them.

Speaking on behalf of the sponsoring organizations that submitted the application were Joseph Geglia, Executive Director, Elmcrest Children's Center who resides at 4789 New Hope South, Liverpool, NY 13090; and Kelly Besaw, Vice President for Development, Christopher Community, Inc., who resides at 415 Fay Road, Syracuse, NY, who gave a brief summary of their organizations' histories and missions, and the purposes of the proposed project.

Jeremy Davidheiser, Director of Facilities and Construction, Christopher Community, Inc., who resides at 4149 Bishop Hill Road, Marcellus, NY, provided a project overview and new information since the last meeting including the proposed sewer lateral location, the elevation change between Edgehill Road and the site, and standards of proof needed for a use variance. Also presenting on behalf of the project was Matthew Huerber, member of the Elmcrest Children's Center Board of Directors, who resides at 4601 Pewter Lane, Manlius, NY.
