## I. Call Meeting to Order

Ms. Tifft called the meeting to order at 8:34 AM.

#### II. Roll Call

Ms. Tifft acknowledged that all Board Members were present except for Ashanti Dickerson, Michael Quigley, David Mankiewicz were excused.

#### IV. Minutes

Ms. Tifft asked for a motion approving the minutes from the February 6, 2020 Board meeting. Mr. Petragnani made the motion. Mr. Greene seconded the motion. ALL BOARD MEMBERS PRESENT UNANIMOULSY APPROVED MINUTES FROM THE FEBRUARY 6, 2020 BOARD MEETING.

#### V. New Business

## **2019 Financial Statements**

Ms. Tifft introduced Michael Lisson, SEDCO auditor from Grossman St. Amour.

Mr. Lisson reviewed the final statements with the board and made a presentation on various metrics including loan performance, net revenues, and an increase in output. Mr. Lisson noted there were no significant issues to report.

The board discussed whether SEDCO should create a formal loan loss reserve account, rather than accounting for individual loans where there is concern about ability to pay back.

Mr. Vavonese and Mr. Ennis agreed they would explore this idea further and talk with Mr. Lisson.

Ms. Tifft asked for a motion approving the 2019 Audited Financial Statements for the corporation. Mr. Petragnani made the motion. Mr. Driscoll seconded the motion. **ALL BOARD MEMBERS PRESENT UNANIMOULSY APPROVED THE AUDITED FINANCIAL STATEMENTS FOR 2019.** 

## **SEDCO COVID-19 Emergency Relief Program Proposal**

Mr. Ennis outlined the structure and format for the proposed emergency loan fund that would be created and used to assist those businesses impacted by the COVID-19 pandemic with board support. He also noted a loan committee would be created for those members who would like to participate and review the loan requests.

Board members expressed their support for the proposal, and noted the importance of having personal guarantees that could be used as collateral.

Mr. Ennis also reported on the status of some borrowers who have already contacted him about difficulty making their next loan payment on April 1.

The board was supportive of creating a 60-90 day forbearance period that would extend out the period of existing SEDCO loans and allow them a two to three month period where no payments are required. This would be documented and could be reported back to the board in future meetings.

Mr. Ennis said he would continue to speak with borrowers and conduct outreach.

Ms. Tifft asked for a motion to a Review request to establish temporary loan fund as proposed to assist businsses affected by the ongoing COVID-19 pandemic. Mr. Greene made the motion. Mr. Petragnani seconded the motion. ALL BOARD MEMBERS PRESENT UNANIMOULSY APPROVED A MOTION TO ESTABLISH THE SEDCO COVID-19 EMERGENCY RELIEF PROGRAM.

Mr. Ennis asked who would be interested in serving on the loan committee.

Mr. Dickerson, Mr. Greene, Mr. Petragnani, Mr. Gross, Ms. Tifft, and Ms. Solomon expressed a desire to participate.

## **Loan Portfolio Report**

Mr. Ennis went over the delinquent report. He said he has been in contact with all the businesses, and will continue to engage with borrowers who are being affected by the pandemic.

## VII. Adjourn

Ms. Tifft asked for a motion to adjourn the meeting. Mr. Greene made the motion. Mr. Petragnani seconded the motion. ALL BOARD MEMBERS PRESENT UNNIMOULSY APPROVED TO ADJOURN THE MEETING AT 9:36 A.M.

Re: SEDCO Microloan Requests | COVID-19 Emergency Relief Assistance

## **BACKGROUND:**

Following completion of the first three rounds of the SEDCO COVID-19 Emergency Relief Program, a series of loan applications were submitted which were reviewed and considered by the Loan Committee. Based upon further discussion, the following requests have been recommended to proceed to the Board of Directors for approval. Information on the applicant, a summary of the request, and the recommended loan amount are included below.

Manlius Duck, Inc. dba Orange Crate Brewing	Bar and restaurant with locations in Manlius and Syracuse seeking assistance to remain open and continue food service, with 2 employees remaining on staff. Seeking financial assistance for payroll, utilities, food inventory, and rent.	\$ 15,000.00		
Peaks Coffee Company Café LLC	An existing SEDCO borrower that has scaled back hours to operate on the weekends, shifting to online orders to go, with 1 employee that remains on staff. Spaghetti Warehouse Restaurant of CNY LLC	Restaurant that was operational for several weeks during COVID-19, and was performing to-go orders with 5 employees that remained on staff.
