## RESOLUTION

As a result of the public health emergency created by COVID-19, the Federal, State and local bans on meetings or gatherings, and pursuant to Governor Cuomo's Executive Order 202.1 issued on March 12, 2020, as amended from time to time, the City of Syracuse Industrial Development Agency (the "Agency") held a meeting on the 16<sup>th</sup> day of February, 2021, at 8:00 a.m., time, electronically which was made available via Webex https://syrgov.webex.com/syrgov/j.php?MTID=m7bd08d58c137b581130e570f962cc2a4; (or by accessing the link on the Agency's website) and using meeting number 179 618 0615 and password 6hmYqYKbY63; or via telephone at (408) 418-9388 with access code: 179 618 0615, in conjunction with the matter set forth below.

The meeting was called to order by the Chair and upon the roll being duly called, the following members were:

The following resolution was offered by Steven Thompson and seconded by Kenneth Kinsey:

RESOLUTION APPROVING CENTERSTATE CEO'S REQUEST TO EXTEND THE TERM OF THE CURRENT COOPERATION AGREEMENT REGARDING THE SYRACUSE BUILD INITATIVE FROM APRIL 30, 2021 TO DECEMBER 31, 2021

WHEREAS, the City of Syracuse Industrial Development Agency (the "Agency") is authorized and empowered by Title 1 of Article 18-A of the General Municipal Law of the State of New York (the "State"), as amended, together with Chapter 641 of the Laws of 1979 of the State of New York, as amended from time to time (collectively, the "Act"), to promote, develop, encourage and assist in the acquiring, constructing, reconstructing, improving, maintaining, equipping and furnishing of industrial, manufacturing, warehousing, commercial, research and recreation facilities, for the purpose of promoting economically sound commerce and industry to advance the job opportunities, health, general prosperity and economic welfare of the people of the State, to improve their recreation opportunities, prosperity and standard of living; and

WHEREAS, to accomplish its stated purposes, the Agency is authorized and empowered under the Act to grant "financial assistance" (as defined in the Act) in connection with the acquisition, reconstruction and equipping of one or more "projects" (as defined in the Act); and

WHEREAS, the Agency has identified a need to enhance opportunities to foster its corporate purposes of advancing job opportunities, health, general prosperity and economic welfare of the people of the State and the residents of the City of Syracuse, New York (the "City"); and

WHEREAS, the Syracuse Build Initiative (the "Initiative"), led by the City, is designed to build an inclusive workforce of City residents to help ensure that the pool of experienced candidates from the local community have access to jobs in the construction field. The Initiative provides training and apprenticeship opportunities through partnerships with developers. contractors and other community partners with the goal of creating a stronger pipeline to meet the City's workforce needs now and in the future; and

WHEREAS, the Agency sees the Initiative as a way to enhance and leverage the benefits provided by the Agency to various projects through enhanced workforce development for the benefit of the residents of the City; and

**WHEREAS**, acting as an intermediary for the program CenterState Corporation for Economic Opportunity ("*CenterState*") has been tasked with design, fundraising, and implementation of the Initiative; and

WHEREAS, at the request of the Company, by resolutions adopted October 15, 2019 and July 21, 2020, the Agency approved its partnering in the Initiative to: (A) allocate a portion of its earned administrative fees in the amount of \$100,000.00 (the "Funding") to support, among other things, the cost associated with: (i) \$56,000 to Work Readiness and Academic Remediation at EOC to enroll at least 36 individuals in Build Ready classes (focusing on basic construction skills, OSHA, basic academic preparation) of which 80% of enrolled participants will secure employment, enter apprenticeship or enter advanced skill training; (ii) \$24,000 to Community Center Collaborative where neighborhood-based Community Centers will recruit at least 200 individuals into Syracuse Build, host orientation sessions and conduct assessments; and (iii) \$20,000 for participant stipends to pay for about 1,700 hours of class time (based on minimum wage) for participants pursuing advanced construction/trades modules (beyond the basic work readiness & academic remediation class); and assuming a 16 week advanced training schedule, this stipend budget would cover 3 individuals' stipends (assuming 35 hour class time per week); and (B) enter into an agreement with CenterState relative to the foregoing, the terms of which are to be negotiated and include demonstrable benchmarks and reporting requirements (the "Agreement"); and

WHEREAS, the Funding furthers the Agency's purposes to promote economic development and provide opportunities to improve prosperity and the standard of living for the residents of the City; and

**WHEREAS**, the Agency and CenterState entered into the Agreement dated as of July 21, 2020 to memorialize the use of the Funding. The Agreement was set to expire on April 30, 2021; and

- WHEREAS, by correspondence dated February 12, 2021, CenterState advised that due to the ongoing restrictions and impacts associated with COVID-19, including but not limited to reduced need for construction workers, CenterState has not been able to fully implement all of the work to be accomplished under the Agreement and has requested the Agency extend the term of the Agreement to and including December 31, 2021 (the "Extension") to allow CenterState time to fully implement the use of the Funding; and
- WHEREAS, representatives of CenterState appeared at the Agency's board meeting and outlined the current status of the initiatives under the Agreement and the plans for ensuring compliance going forward; and
- WHEREAS, pursuant to Article 8 of the Environmental Conservation Law of the State of New York, as amended, and the regulations of the Department of Environmental Conservation of the State of New York promulgated thereunder (collectively referred to hereinafter as "SEQRA"), the Agency is required to make a determination as to whether the "action" (as said quoted term is defined in SEQRA) to be taken by the Agency may have a "significant impact on the environment" (as said quoted term is utilized in SEQRA). The Agency has classified the execution and delivery of the Agreement as a "Type II" action as that term is defined under SEQRA, and therefore no further review is required.
- **NOW, THEREFORE**, be it resolved by the members of the City of Syracuse Industrial Development Agency, as follows:
- <u>Section 1.</u> Based upon the representations made to the Agency, the Agency makes the following findings and determinations:
- (A) The action authorized pursuant to this Resolution constitutes a Type II action under SEQRA and no further review is required; and
- (B) The Agency authorizes and approves the Extension as set forth herein; and.
- (D) The Executive Director of the Agency is hereby authorized, on behalf of the Agency, execute and deliver any amendments or other documents necessary to evidence the Extension, in in accordance with the terms hereof and to do such further things or perform such acts as may be necessary or convenient to implement the provisions of this Resolution. The execution thereof by the Executive Director shall constitute conclusive evidence of such approval.
- <u>Section 2.</u> Should any court of competent jurisdiction determine that the Agency is not authorized under the Act to participate in the Extension, this Resolution shall automatically become null, void and of no further force and effect.
- <u>Section 3.</u> No covenant, stipulation, obligation or agreement contained in this resolution or any document referred to above shall be deemed to be the covenant, stipulation, obligation or agreement of any member, officer, agent or employee of the Agency in his or her individual capacity. Neither the members nor officers of the Agency, nor any person executing

any documents referred to above on behalf of the Agency, shall be liable thereon or be subject to any personal liability or accountability by reason of the execution or delivery thereof.

Section 4. A copy of this Resolution shall be placed on file in the office of the Agency where the same shall be available for public inspection during business hours.

<u>Section 5.</u> The Secretary of the Agency is hereby authorized to and may distribute copies of this Resolution and to do such further things or perform such acts as may be necessary or convenient to implement the provisions of this Resolution.

<u>Section 6.</u> This Resolution shall take effect immediately. A copy of this Resolution shall be placed on file in the office of the Agency where the same shall be available for public inspection during business hours.
