WHEREAS, Section 5-205-A of the Charter of the City of Syracuse, as amended, provides the Mayor shall "award contracts for professional services subject to the approval of the Common Council"; and

WHEREAS, the Mayor has approved the retention of UMR (formerly POMCO, Inc.), under the following terms:

- (1) UMR (formerly POMCO, Inc.) shall provide third party administration services for medical and dental insurance for the City of Syracuse for all currently enrolled active officers and employees and for new eligible officers and employees and retirees under age sixty-five (65);
- (2) The duration of this agreement shall be for one year effective as of January 1, 2016 through December 31, 2016 with the option for the City of Syracuse to renew for four (4) additional one-year terms, subject to necessary approvals by the Mayor and Common Council for the City; the agreement was previously extended for the first, second, third and fourth renewal period effective through December 31, 2020; the Agreement is hereby further extended for a one (1) month period to allow for the transition of all remaining Local 280 Bargaining Unit Firefighters and Deputy Chiefs to Excellus Blue Cross Blue Shield:
- (3) The City shall pay to UMR (formerly POMCO, Inc.) an estimated amount not to exceed \$1,000,000 annually for all services to be performed pursuant to the terms of the agreement and in accordance with the proposed fee schedule per enrollee attached hereto as Appendix "A"; the City shall pay to UMR an amount not to exceed \$100,000.000 for all services to be provided under this amended agreement;

NOW, THEREFORE,

BE IT ORDAINED, that the Mayor, be and he hereby is authorized to execute such amended agreement, as hereinabove stated, subject to the approval of the Corporation Counsel as to terms, form and execution; and

- 2) The rate will be \$50.00 per parking space per month.

The lease agreement shall be subject to the approval of the Corporation Counsel as to terms, form and content.

- WHEREAS, pursuant to Part C, Section IV, Article 2-7, paragraph b of the City of Syracuse Zoning Rules and Regulations, as amended, Care Homes shall be subject to all of the regulations applicable to permitted uses in the District within which such Care Home is to be situated; and
- WHEREAS it was noted during the public hearing that both the Federal Fair Housing Act and New York State Human Rights Law prohibit housing discrimination based on disability, including discriminatory land use and zoning laws and practices by local governments; and
- WHEREAS, the Commission considered all public comment presented during the hearing, particularly the concerns of the Executive Director of CNY Fair Housing, Sally Santangelo, and the organizations signing on in support of that letter, which presented an argument that outlined the Department of Housing and Urban Development and the Department of Justice identified the following examples of zoning and land use laws that may violate the Fair Housing Act;
 - Imposing restriction or additional conditions on group housing for persons with disabilities that are not imposed on families or other groups of unrelated

individuals by, for example, requiring an occupancy permit for persons with disabilities to live in a single-family home while not requiring permit for other residents of single-family homes;

• Imposing restriction on housing because of alleged public safety concerns that are based on stereotypes about the residents' or anticipated residents' membership in a protected class by, for example, requiring a proposed development to provide additional security measures based on a belief that persons of a particular protected class are more likely to engage in criminal activity; and

NOW THEREFORE BE IT RESOLVED that We, the duly appointed members of the City Planning Commission of the City of Syracuse, do this 14th day of December, 2020, DISAPPROVE WITHOUT PREJUDICE the proposal from the City of Syracuse Common Council for a Text Amendment to the City of Syracuse Zoning Rules and Regulations, as amended, to require a Special Permit review for a Care Home within Commercial, Class A, Commercial, Class B, and Industrial, Class A zoning districts, for the following reason(s);

- 1. The proposed Text Amendment did not include any studies, data, or related information that justify the impetus or need to amend the City of Syracuse Zoning Rules and Regulations, as amended, as proposed;
- 2. The proposed Text Amendment did not include specific approval criteria which would supersede development standards already established for Commercial, Class A, Commercial, Class B, and Industrial, Class A zoning districts.
- 3. Information presented during the public hearing relating to the revision caused concern for potential violations of both the Federal Fair Housing Act and New York State Human Rights Law prohibiting housing discrimination based on disability. Therefore, the Commission deemed that more information and research would be needed in order the Commission to consider the proposed amendment within the time allowed for review under local law.

WHEREAS, New York State passed the COVID-19 Emergency Eviction and Prevention Act of 2020 which included a provision that local governments are required to carry over Senior Citizens' Homeowners Exemptions and Disabled Homeowner Exemptions from the 2020 assessment roll to the 2021 assessment roll at the same levels until May 1, 2021; and

WHEREAS, the law states that "every governing body of an assessing unit and local assessor shall extend to the 2021 assessment roll, the renewal of the fourteen (14) exemptions received on the 2020 assessment roll pursuant to sections 467 and 459-c of the real property tax law, relating to persons age sixty-five and older and for certain persons with disabilities and limited income, and no renewal application shall be required of any eligible recipient who received either exemption on the 2020 assessment roll in order for such eligible recipient to continue receiving such exemption at the same amount received on the 2020 assessment roll, except as here-in provided. Provided however, that the local assessor shall make available renewal applications through postal mail or electronic means in order for eligible recipients to file renewal applications in the event that such eligible recipient determines his or her income has changed in a manner that would grant him or her a greater exemption than what was present on the 2020 assessment roll; and provided further that such governing body may adopt a local
