Dance One Night License Instructions

Overview: This license is required for public dance events in the City of Syracuse to ensure they operate in accordance with the law and do not endanger citizens' health, safety, and welfare. It also ensures police and fire personnel have been notified of the event. For more information, [click here to read the Ordinance](#).

License Requirements:

- The property or business owner of the space where the event is being held must apply.
- The license must be issued per event. Each dance must have its own application.
- A City review must be conducted before the license is issued.
- Private dances in private homes, clubs, or organizations, where attendance is restricted to members only, are exempt from this license.
- The license may be revoked through a hearing by the chief of police if the ordinance has been considered violated.
- Certificate must be posted conspicuously in window or door during the event.

Application Checklist:

- Completed Dance One Night License Application (pages 2 to 3). The application must be signed in the presence of a notary public.
- \$10 Application Fee. Check or Money Order payable to Commissioner of Finance.
- Copy of Applicant's Photo Identification: Driver's License, Passport, or equivalent.

Submittal Instructions:

1. Application must be completed in its entirety. Incomplete applications will not be processed.
