Junk Dealer License Instructions

Overview: This license is required for persons engaging in the business of junk dealing in the City of Syracuse, involving the wholesale and/or retail business of purchasing and/or selling worn goods, from or within a yard or other fixed premises. License Requirements:

- The license must be renewed every year. The license expires on December 31 of the year it is issued.
- No license will be given to a person who has been convicted of larceny or knowingly receiving stolen property.

Application Checklist:

- Completed Junk Dealer Application (pages 2 to 3). The application must be signed in the presence of a notary public.
- \$150 Application Fee. Check or Money Order payable to Commissioner of Finance.
- Copy of Applicant's Photo Identification: Driver's License, Passport, or equivalent.

Submittal Instructions:

1. Application must be completed in its entirety. Incomplete applications will not be processed.
2. Application, fee, and document must be submitted to:
